

The experiences operated by Drift Limits Limited ("Drift Limits") include the use of high powered motor vehicles, and performing various manoeuvres in those vehicles which push them beyond their normal operational use (including deliberately losing traction (drifting) and stunt driving). Whilst Drift Limits takes every participant's safety seriously and, as will be explained to you in the safety briefing, has designed the tracks to keep everyone as safe as reasonably possible, there are various risks inherent with such activities which cannot be avoided altogether. These include the risk that you may suffer harm as a result of:

- A. motor vehicles (or parts of them) colliding with other motor vehicles, persons or property;
- B. motor vehicles losing control and possibly rolling over;
- C. motor vehicles catching on fire;
- D. acts of violence and other harmful acts (whether intentional or inadvertent) committed by persons attending or participating in the event; and
- E. the failure of facilities (including grand-stands, fences and guard rails) designed to ensure the safety of persons or property at the event.

By signing these terms & conditions, you accept and acknowledge the risks arising from attending or participating in the Drift Limits experiences. You further agree and confirm as follows:

I agree that I will carry out the experience in accordance with the specific safety briefing instruction that I will receive before undertaking the experience.

I agree to wear any safety equipment provided by Drift Limits in accordance with their instructions and shall ensure my safety at all times.

I understand that the experience requires a moderate level of fitness and is physically testing.

I accept that there is a risk of injury when undertaking such activities.

I confirm that I am not suffering from any illness or disability whether permanent or temporary which will affect my control of the vehicles being driven or instruction being taken.

I confirm I hold a valid UK/International driving licence which I have presented at reception or have made previous arrangements with Drift Limits which nullifies the need for a license.

I further agree, in exchange for being to attend or participate in the experience(s):

1. to release Drift Limits Limited ("Drift Limits") and any promoters, sponsor organisations, land owners and organisers of the event, their respective employees, officials, representatives sub-contractors and agents (collectively, the "Associated Entities") from all liability for my death, personal injury (including burns), psychological trauma, loss or damage (including property damage and loss or damage to personal possessions) ("harm") howsoever arising from my participation in or attendance at the event, whether caused by the negligence of any of the Associated Entities or otherwise, except that the liability of any of the Associated Entities carrying on a business is not limited in relation to death or personal injury arising from negligence on the part of any such Associated Entities;
2. to indemnify the Associated Entities and each of them from any loss, liability, damage or cost they may incur arising out of or relating to my attendance at or participation in the event;
3. to attend or participate in the event at my own risk and voluntarily assume all risks; and
4. that this release and waiver of liability, assumption of risk and indemnity agreement extends to all acts of negligence by the Associated Entities, save for the exception in paragraph 1 above, including negligent rescue operation, and is intended to be as broad and inclusive as is permitted by law, and that if any portion thereof is held invalid, it is agreed that the balance shall notwithstanding continue in full legal force and effect.

I accept the conditions of, and acknowledge the risks arising from, attending or participating in the event and being provided with the event services of Drift Limits. I agree that I will carry out the experience in accordance with the specific safety briefing instruction that I will receive before undertaking the experience. I agree to wear any safety equipment provided by Drift Limits in accordance with their instructions and shall ensure my safety at all times. I understand that the experience requires a moderate level of fitness and is physically testing. I accept that there is a risk of injury when undertaking such activities.

I have had sufficient opportunity to read this release and waiver of liability (overleaf), assumption of risk and indemnity agreement, and I fully understand it's terms. I understand my signature to this document constitutes a complete and unconditional release of all liability of the Associated Entities to me in relation to the event to the greatest extent allowed by law.

**Optional Damage Waiver**

Drift Limits have agreed that on my purchase of this optional damage waiver, should there be any accidental damage whatsoever to any of the Drift Limits vehicles I drive today applicable to the waiver purchased (as set out below), I will not have to bear any responsibility for the costs of repair notwithstanding the Damage Liability section of these terms and conditions. The damage waiver is **void** if I am found to be driving negligently or dangerously. This damage waiver is non refundable.
